Top View



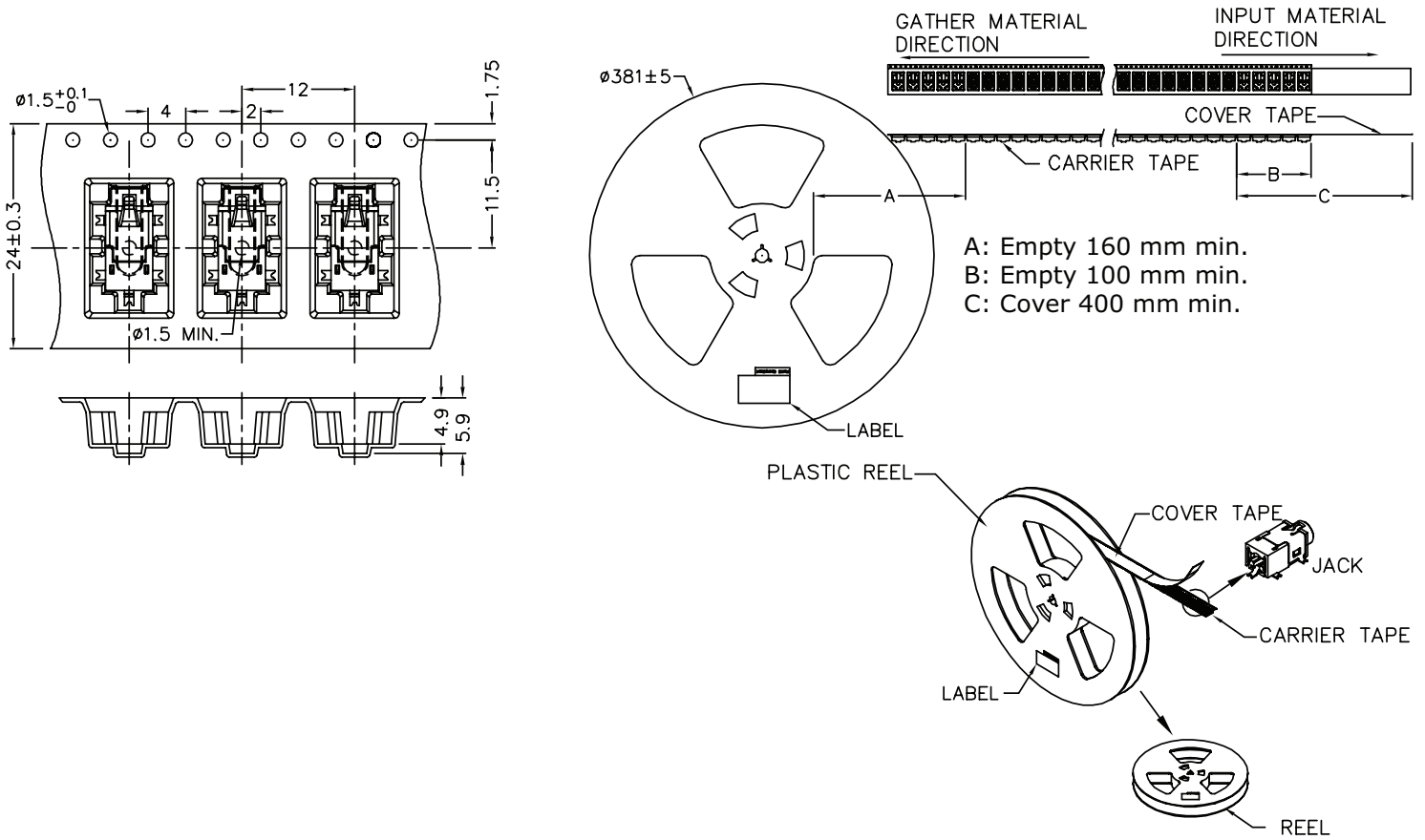
